The difference between "infrastructure" and who has jurisdictional control it sounds to me that we are having trouble connecting. And it is not necessarily anyone's fault to know about who is responsible for what, it is a lot of information for many when I naturally talk about this in person.

The road expansion for 205 will not proceed until all of the utility lines have been relocated. There is an entire timeline that occurs that included public hearings in 2018, environmental studies, city negotiations, road consortium input, to contractor bids, monthly zoom meetings with all of the utility reps to check on their process with engineering to bids, loan applications, easement purchases, etc. There is a lot that goes into expanding a state road.

- The services that you speak about come in phases that are budgeted. This is a 25 year long project. So this idea of what Rockwall citizens are left to deal with consequence of x amount homes won't be really be an issue. Why? Very soon the Regional Transportation Council (RTC) is going to determine the outer loop direction and funding. Whether Rockwall County has a seat at the table or not. This is "state/federal" project. Yes, I hear that many may be against it, but it is coming. This is not a county road project. I hope that makes sense.
- State Hwy 205 will most likely be expanded within the next decade.
- We are definitely behind on infrastructure. That is why we need leadership to manage the growth. That is why we need the change of County Judge and Commissioners that are not doing their job.
- The Outer Loop will alleviate traffic from 205 and 276 as that was discussed in previous meetings. We also need the loop for mobility purposes for those on the south and north to connect. They have produced studies on traffic flow and patterns.
- There will be some benefits from the Outer Loop, economically, it might be more on the northern end as there is a lot of flood plain on the southern portion.
- There will also be a traffic improvement to have the Outer Loop as well, BUT I would rather have our people have a seat at the table so that we can expand those benefits.

Sebastian August, YES I believe that we should have a Fire Service agreement for any NEW development out in the ETJ and/or County. In fact, McLendon-Chisholm has fire service agreements to pay for labor dating back for several years with developments out there. River Rock Trails has a viable fire service agreement since April 2024 that they will pay for the cost of a new fire station in the first phase that will not only service that development but also in the county. It also included equipment and labor to pay to the City of McLendon-Chisholm to staff that substation. Below, I am linking my article that includes the agreement.

POLICE

The MUD could certainly have their own police service. However because this is in the County the budget should manage the growth accordingly. Clearly we have extra funding for several lawsuits for their office and personal capacity that could be used to pay for new deputies and meeting the department needs.

SCHOOLS

The school district is their own jurisdiction. The County has no authority in building schools. The school district has an entire department that manages looking at school sites to the process of presenting to the school board of what is needed to have a school bond election. In fact, the best person to speak on the subject is the school board president for Royse City ISD which is the candidate running for County Judge Scott Muckensurm. The County can't just create a one page interlocal agreement with a school district demand for the developer to cut a check to the County and then pay the school district. That's not the lawful process to build schools and it is government overreach to tell a school district you must build a school right there or over there. The school district has their own goals and priorities.

ROADS

The MUD is required by law to build roads that benefit their district. So that is already established. As far as FM 548 goes, they already worked with TxDOT on what is needed to address their portion. FM 548 is managed by the state/TxDOT not Rockwall County. What other roads are we missing that hasn't been addressed by this developer?

Unless you live in the MUD you are paying for those specific taxes as well as those specific services. If you are in the Royse City ISD jurisdiction yes all property owners will vote to approve school bonds and those monies fund the maintenance and operation of the school district. There will not be a new school bond placed on a November ballot to accommodate the current preliminary plat. That's just not how it works for the school district to build new schools.

All property owners have a line item to pay County taxes. Those monies fund their existence that includes the sheriff's office. And if we are all about managing our growth and support our law enforcement we should support those county budgets to meet those needs. Sheriff Garrett and other deputies have been doing a great job in presenting their needs. I don't think we do enough for dispatch and county jail related services for mental health cases. How do we improve that? And at what cost? I would lean on the sheriff's office to present what can we do to improve their needs.





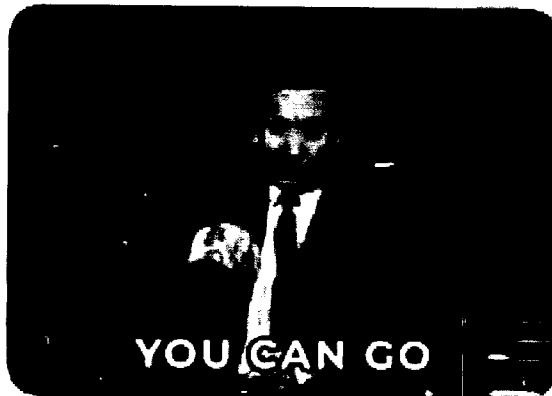


